Quick Business Terms defined:

Earnings before interest and taxes (EBIT): A financial measure defined as revenues less cost of goods sold and selling, general, and administrative expenses. In other words, operating and non-operating profit before the deduction of <u>interest</u> and income taxes.

Speculative grade bond: <u>Bond</u> rated Ba or lower by Moody's, or BB or lower by S&P, or an unrated bond.

Investment grade bond: A <u>bond</u> that is assigned a rating in the top four categories by commercial credit rating companies. For example, S&P classifies investment grade bonds as BBB or higher, and Moodys' classifies investment grade bonds as Ba or higher. **Related:** <u>High-yield bond</u>.
