Terms and Conditions

1.MathSciNet. MathSciNet is the online version of the AMS publications Mathematical Reviews, **from** 1940 to the current issue, and Current Mathematical Publications. The AMS reserves the right to add or delete MathSciNet content at any time.

2. Scope of License. Use Restrictions. The license includes authorization of **access** by means of specific **IP** addresses of Consortium members to allow site-wide online access by authorized users at Consortium member sites via multiple connections. Authorized users must be employees, faculty, staff, or students officially **affiliated** with a member organization of this Consortium, or authorized on-site clients of a Consortium member's **library** facilities. This license also includes remote access to authorized users via **secure proxy** servers maintained by Consortium member sites. Each Consortium member will make reasonable efforts to inform authorized users that they are entitled to access MathSciNet to:

a. make searches of MathSciNet

b. make one or more copies in hard copy form of the output of any

search; such copies may not be sold and may not be distributed to anyone who is not an authorized user; and

c, **download** search results to hard disk or diskette, provided that such

data is not made available to anyone who is not an authorized user.

Each consortium member will make reasonable efforts to inform authorized users that they may not make MathSciNet available to anyone **other** than another authorized user. Each Consortium **member** is responsible for making reasonable efforts to provide security and to prevent unauthorized use from its respective site:

3. Access. **MathSciNet** access is granted site-wide only to those **IP** addresses specifically listed in this agreement (numeric IP domain addresses are preferred). Consortium members may request access for any number of **IP** addresses; however, usage must be restricted to a single site. **IP** domains supporting usage from other sites are specifically **prohibited** unless those other sites are listed as Consortium members in this agreement. If a site can not preclude access by remote sites, then those sites are required to be included as Consortium members.

4. Term and Fees. Upon payment of Consortium Data Access Fees (DAF) and MathSciNet Consortium fees and acceptance of this agreement by the AMS, each site in the Consortium is entitled to all rights of an institution that has paid a Data Access Fee including the rights to purchase Mathematical Reviews products (e.g. classic MR print). Contact Customer Services for additional information. This Agreement will last through the end of 2000. This Agreement will remain in effect thereafter for successive calendar years so long as all applicable fees are paid. The Consortium or the AMS may terminate this Agreement, effective on the next renewal date, by at least 30 days written notice to the other party. The annual Consortium Data Access fee and annual MathSciNet license fee may be raised by written notice to the Consortium Contact, given at least three months prior to the next succeeding renewal date. The fees for each year this Agreement is renewed must be paid by the Consortium on or before the renewal date or the renewal will be invalid. The AMS is not responsible for the collection of any fees owed by Consortium members to the Consortium or any refunds owed by the Consortium to Consortium members. New Consortium members may not be granted MathSciNet access without explicit approval from the AMS, A Consortium member may withdraw at any time from the Consortium, provided written notice of such withdrawal is given to the AMS, but withdrawal during a calendar year will not entitle the Consortium or said member to any fee rebate from the AMS.

5. Support. MathSciNet includes online documentation. In addition, the AMS will provide Consortium **members** (and individuals at those sites) with e-mail and/or telephone support service during **AMS's** normal business hours (Monday-Friday, 9:00am to 4:00 PM, **ET)**: The e-mail address for support questions is **msn-support@ams.org**; the telephone number for support is 800-32 1-4267, extension 4048 or 401-455-4048.

6.Copyright. MathSciNet and its contents are subject to copyright, database protection, and other rights of the publisher **(AMS)**, under the laws of the United States and the country of use. Consortium members acknowledge that they have no claim to ownership by reason of its use of or access to MathSciNet. Downloading of data is permitted **solely** for Consortium member internal use to the same extent as the printed version of the publication. Recompiling, systematic copying, publication or republication of the data, or any portion thereof, in any form or medium whatsoever, may be done only with specific written permission from the AMS. 7. Suspension or termination of access. If the AMS becomes aware of a material breach of the rights granted to the Subscriber under the Agreement that the AMS reasonably believes will cause immediate and severe economic injury, the AMS will notify the Subscriber immediately and shall have the right to temporarily suspend the Subscriber's access to the MathSciNet. Once the breach has **been** remedied or the breaching activity **halted**, the Publisher **will immediately** reinstate access to MathSciNet. If the Subscriber does not satisfactorily remedy the breaching activity within thirty (30) days, the Publisher may terminate this Agreement upon written notice to the Subscriber.

- c. Consortium members will be permitted to access MathSciNet at any time. The AMS will not be liable for any delay, down time, or other failure of performance, but will use reasonable efforts to correct any performance problem brought to its attention.
- **d.** The AMS will not be responsible for incidental, consequential, or any other damages arising out of or in connection with the service or materials provided hereunder.

It may be amended only by a written instrument signed by both parties (AMS and the Consortium Contact). Without **limitation** of the foregoing, any purchase order or other instrument that the Consortium may issue for MathSciNet is for the Consortium member's internal purposes only and **will** in no way modify, add to or subtract from the terms and conditions provided herein.
- b. Neither the Consortium nor any of its members may assign or transfer any rights under this Agreement.
- c. The benefits of this Agreement, including but not limited to MathSciNet access, will be available only to Consortium members that have executed an Acknowledgement of Consortium Subscription Agreement Terms and Conditions in the form attached hereto as Exhibit A.
